

William Shackelford NARFE National President

William "Bill" Shackelford began his federal career in 1971 with the Federal Bureau of Investigation, serving nearly 35 years in various training, analytical, and management positions, including fingerprint identification, review, and distribution of records relative to the assassination of President John F. Kennedy, training in the archival preservation of historical records and the management of litigations filed under the Freedom of Information and Privacy Acts before retiring in January 2006.

A Life Member of NARFE, Bill is a member of Fairfax Chapter 737, having held Chapter positions including Service Officer, Newsletter Editor, Vice President, and President. Within the Virginia Federation of Chapters, he has served as Second Vice President, First Vice President, and President. On the NARFE National level, he served at the 2012 National Convention, in Sparks, Nevada, as Chair of the Timekeeper Committee, from March 2013 through April 2014 as Chair of the 2013 National Bylaws Committee, from August 2013 through February 2014 as Co-Chair of "Future Of NARFE" Committee and at 2014 in Orlando, Florida, as Chair of 2014 Bylaws Committee. At the 2014 NARFE National Convention in Orlando, he was first elected Region X Regional Vice President. During his tenure as Regional Vice President, he served on the Executive Director Search Committee from November 2016 through May 2017, was a member of the 2021 Strategic Planning Team, and for 2021–2022, as Chair of the National Membership Advisory Committee

Bill graduated in 1971 from Northern Virginia Community College with an Associate Degree majoring in Law Enforcement Science and in 1974 from American University with a Bachelor of Science Degree majoring in Judicial Administration.

A native Northern Virginian, born in Arlington and raised in Fairfax, Bill currently lives in Centreville, Virginia, with his wife, Donna. Together, they have four children and seven granddaughters, one great-granddaughter, and one great-grandson.

She joined NARFE in February 2007 as an active member. Reese immediately started working on the Chapter 182 board. The positions held were President, Vice President for Legislation, FEEA, and numerous Conference Chair positions. In 2008 active at the New Mexico Federation level, she held positions as President, Vice President for Legislation, and Conference Chair.

At Region VII, she held the FEEA Coordinator position and was a candidate for National Committees.

Education included classes at the University of Illinois, Wharton School of Management at Syracuse University, and numerous courses sponsored by the United States Army at Rock Island, Illinois, and Ft Belvoir, Virginia.




John HattonStaff Vice President, Policy and Programs

John Hatton is the Staff Vice President for Policy and Programs at the National Active and Retired Federal Employees Association (NARFE). In this position, Hatton directs the association's public policy activities, leading NARFE's advocacy on behalf of the earned rights and benefits of America's active and retired federal workers. Hatton also directs the association's programs department, which provides educational content and personal assistance related to federal employment benefits to NARFE members, and manages the association's annual conferences. Prior to his promotion in December 2021, Hatton served in various roles as a member of NARFE's Advocacy Department since July 2010.

Hatton originally hails from Lake Grove, NY, on Long Island, and now lives in Alexandria, VA, with his wife and their 5- and 3-and-half-year-old sons.



Frank Impinna
Colorado Federation President

Frank Impinna was born and raised in California. He began his career with the Postal Service in 1961, and during that time, he enlisted and spent four years in the US Air Force as a Control Tower Operator. After receiving his Honorable Discharge, he returned to the Postal Service and retired 26 years later as a Distribution Mail Center manager. As a manager, he became involved in and was a leader for the National Association of Supervisors (NAPS). He worked in all facets of the Postal Service, from being a carrier, distributing and sorting mail, and as a Master Instructor for initial-level supervisors in the Western Region.

Throughout his career, he pursued and received a master's degree in business administration and organizational management, always continuing to move up the ladder in executive positions. Frank became a NARFE member in 1994, as an active employee with the US Postal Service, and became a Life Member the following year at the age of 53 while still employed. Soon after, he became vice president of Lakewood, California Chapter 2025 and was president from 2000-2009. In 2007 he was also elected as District Vice President on the California Federation Board, serving eight (8) Chapters within his district. He also served as an instructor for Federation and District Training Seminars for all chapter disciplines, attended and worked on the National Legislative Standing Committee from 2005-2007, and served on several Federation State Convention committees.

In 2009 he was elected Colorado Federation President and made strides to better the Federation in Membership and Retention, Officer Training, Web site enhancements, and Communications throughout the state. In 2012 he was elected for a two-year term as Regional Vice President for Region VII. In 2014, he became Federation Vice President Membership until 2022. He is now the interim Federation President of Colorado.

What to do in case of death!

The National Active and Retired Federal Employees Colorado Federation wishes to express our deep sympathy for the loss of your loved one. Here is some crucial information to help report the death to the Office of Personnel Management (OPM) and claim any death benefits that might be due.

You can notify OPM online, by email, in writing, or by phone. Whichever method you choose, you must include the annuitant's retirement CSA or CSF claim number along with their Social Security number. This information is found on their last tax return forms, 1040 and 1099-R.

- ✓ To notify online, go to https://rsreporting.opm.gov/AnnuitantDeath/ReportAnnuitantDeath and follow the instructions.
- ✓ To notify by email, send a message to retire@opm.gov.
- ✓ To notify in writing, send a note to OPM RETIREMENT OPERATIONS CENTER, P.O. Box 45, BOYERS, PA
 16017-0045, ATTN DEATH CLAIMS
- ✓ To notify by phone, call OPM at 1-888-767-6738 (toll-free). This is often the most challenging way, as it may be hard to get through to a representative.

After you notify OPM, you should receive an Application for Death Benefits and a Life Insurance Claim for Death Benefits in the mail in about three weeks, so be sure to give them a mailing address for the person who should receive these forms.

If the deceased received any payments from the Social Security Administration, they must be notified. The funeral home can do this for you. Be sure to discuss this with them. Also, be sure to request plenty of certified copies of the death certificate since most of your notifications will require them.

If the deceased was an armed forces veteran, go online to the Department of Veterans Affairs at va.gov to search for any benefits you may be entitled to, such as help with burial expenses or an Arrears of Pay payment if applicable.

If you are the spouse, you may want to change your health insurance enrollment to "self only" unless you have other family members covered, and you may wish to change your tax withholding amount since the single filing status is at a higher tax rate. You can contact OPM to do both of these.

IMPORTANT: You must return any annuity check made out to the deceased that was issued after their death. It cannot be legally cashed by anyone else, even an estate executor. You must notify the bank if the annuity payment was a direct deposit to an account. OPM will ask the Treasury Department to recover it from the bank. If the annuity check was received in the mail, you must return it to the return address on the envelope.




